## **Chamber of Commerce for Greater Moncton celebrates ‘year of change’ in 2018 at AGM**

The Chamber of Commerce for Greater Moncton (CCGM) elected a new board of directors at its 128th Annual General Meeting held Wednesday, May 15 at the Dieppe Wingate Hotel.

The Chair of the Board of the CCGM, Geneviève Laforge, designated 2018 as a year of great change and growth for the organization representing the business community of Greater Moncton. The Chamber was able to solidify its involvement in the community with an increase in the number of members, multiple meetings with stakeholders and a higher presence in media, as well as an excellent year in attendance in its multiple events.

In 2018, the staff of the Chamber was able to build the right foundation for sustained growth in membership, increased community presence and brand strengthening.

For the CEO of the Chamber, John Wishart, one of the main priorities for the CCGM in 2018 was marketing and branding of the organization. All efforts resulted in a new marketing strategy with a new logo, tagline ‘Inspiring Growth’, new website, and even a new name.

“The Chamber of Commerce brand needed an update. We had been using the same name since the 70’s, and the same logo since the 80’s. Our new name focuses on ‘for Greater Moncton’, because the Chamber does stand for something, for the growth of our people, for our businesses and for our community”, said Wishart.

The Chamber also took its role of representing the business community to heart by giving a voice to its members, representing them on key public policy issues like Worksafe NB rates, the carbon pricing federal backstop, and the introduction of a hotel marketing levy in Greater Moncton.

Wishart thinks that every initiative taken by the CCGM must bring more value to its members.

“In the future, we want to show our members, and prove to them that their investment in the Chamber of Commerce can bring them real dividends and real value”, he said.
